

Installation requirements

All rails must be fixed to a suitable wall substrate to allow correct use to be made of the rails. The Splash Lab recommended that installers contact a fixings specialist for advice to ensure the correct fixings are used for the location. Fixings not included with rail.

Load Capacity Information

In the UK, the load capacity of grab bars is typically governed by the British Standard BS 8300:2018 "Design of an accessible and inclusive built environment" and the Building Regulations. While BS 8300:2018 does not specify an exact load capacity for grab bars, it emphasizes that grab bars should be robust and capable of supporting the weight of a person. The grab bars should be securely xed to the wall and able to withstand signicant force without becoming loose or detached.

In Ireland, the load capacity of grab bars is governed by the Disability Act 2005 and the Technical Guidance Document M (TGD M) of the Building Regulations. Similar to the UK, TGD M requires grab bars to be strong and sturdy, capable of supporting the weight of a person without failure.

While specic load capacity values may not be explicitly stated in the standards, the general principle is to ensure that grab bars are designed and installed to accommodate the needs of individuals with disabilities, including those who may require additional support while using bathroom facilities or other accessible areas.

To comply with the relevant accessibility standards, it is essential to use high-quality grab bars designed for commercial or institutional use and follow the manufacturer's recommendations regarding load capacity and proper installation.

Architects, building owners, and contractors involved in designing and constructing accessible facilities should consider the load capacity requirements in the respective accessibility standards to ensure the safety and usability of grab bars for all users, including those with disabilities.


